**UPGRADATION OF ITI**

3314. SHRI HARBHAJAN SINGH

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to State:

- (a) whether there is any proposal to upgrade Industrial Training Institute (ITIs) across the country during the next financial year;
- (b) if so, the details thereof and financial allocation therefor;
- (c) whether any ITI from Punjab will be included in the upgradation plan; and
- (d) if so, the details thereof along with financial allocation thereto?

**ANSWER**

THE MINISTER OF STATE FOR THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(a) Industrial Training Institutes (ITIs) are the important part of the skill network, most of the ITIs are run by the State Governments and Private entities are authorized by State Governments. There are few NSTIs which are directly managed by Central Government.

The upgradation/modernization of State ITIs are responsibility of the State Government/UT administrations. However, the Central Government is implementing some schemes under which grant-in-aid is released to the State Governments for upgradation of their Industrial Training Institutes (ITIs).

Under these schemes, a few ITIs are selected and the State Governments are provided funds for their upgradation. The schemes currently running are:-

- i. Upgradation of existing Government ITIs into Model ITIs
- ii. Enhancing Skill Development Infrastructure in NE States
- iii. Skills Strengthening for Industrial Value Enhancement (STRIVE)

Funds under the scheme are released to the State in each financial year, during the currency of the scheme, and the amount of fund released depends upon the Utilisation Certificates (UCs) provided by the State Government in respect of the funds released to them in the previous years.

(b) The total outlay of the scheme and the funds released State-wise is given in *Annexure I*.

(c & d) Yes Sir, under the Scheme “Upgradation of existing Government ITIs into Model ITIs”, Government ITI, Rupnagar (Ropar) in the State of Punjab is covered with a central allocation of Rs. 7 crore and so far, an amount of Rs. 3.5 crore has been released for ITI Rupnagar. Funds will be released in FY 2023-24 upon submission of UCs and progress reports by the State Government of Punjab.

In addition, under the STRIVE project a total of 24 ITIs (which includes 23 Government and 01 Private ITI) from the State of Punjab have already been selected under STRIVE project and the details of the ITIs along with the financial allocation and funds released is annexed at *Annexure-II*.
