STORAGE FACILITY TO FARMERS

3426 SHRI VIJAY PAL SINGH TOMAR:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether the storage facilities provided by Government to the farmers in the country are sufficient and if so, the details thereof;
- (b) whether Government is contemplating provision of additional storage facility within the country;
- (c) if so, the details thereof, State/UT-wise; and
- (d) if not, the time by which it is likely to be contemplated?

A N S W E R MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

- (a): Food Corporation of India (FCI) mainly stores Wheat & Rice after procurement for Public Distribution System (PDS) operation and to maintain buffer stock. As on 01.03.2023, Covered Storage Capacity available with FCI and State agencies for storage of Central Pool foodgrain stock is 714.82 Lakh MT against stored stock of 321.23 LMT.
- (b) & (c): FCI continuously assesses and monitors the storage capacity and based on the storage gap assessment, storage capacities are created/hired through the following schemes: -
- 1. Construction of Silos under Public Private Partnership (PPP) mode
- 2. Private Entrepreneurs Guarantee (PEG) Scheme
- 3. Central Sector Scheme (CSS)
- **4.** Hiring of godown from Central Warehousing Corporation (CWC)/ State Warehousing Corporations (SWCs)/ State Agencies
- 5. Hiring of godown through Private Warehousing Scheme (PWS)

Initiatives for developing efficient storage system are as under:

Silo-

Rail Side Silos-

In order to upgrade and modernize the storage facilities, Government of India approved Action Plan for construction of steel silos on PPP (Public Private Partnership) mode in the country. Under this plan a capacity of 12.75 LMT is completed and a capacity of 11.50 LMT is under implementation. The State-wise details are at Annexure-I.

Hub & Spoke Silos-

Under Hub & Spoke model of silos, in phase-I tenders for 10.125 LMT at 14 locations on FCI own land and 24.75 LMT at 66 locations of private land have been awarded. State-wise details are at Annexure-II.

PEG Scheme- Under the PEG Scheme, construction of conventional godowns has been undertaken in 22 States by attracting private investment. PEG Scheme was initiated in 2008 and is in its last phase. Total capacity sanctioned for godowns as on 01.03.2023 is 152.25 LMT. Out of this, 146.14 LMT has been completed and 5.11 LMT is under construction. State-wise details are at Annexure-III.

Centre Sector Scheme- This scheme is implemented in the North Eastern States along with Himachal Pradesh, Kerala, Jammu & Kashmir and Jharkhand. As on 01.03.2023, a capacity of 74,510 MT has been created and a capacity of 62,800 MT is under construction. State-wise details are at Annexure-IV.
