#### ASSISTANCE TO PROMOTE HANDICRAFTS OF HIMACHAL PRADESH

#### 3512. DR. SIKANDER KUMAR:

Will the Minister of TEXTILES be pleased to state:

- (a) the steps taken by Government to promote Handicrafts of Himachal Pradesh globally;
- (b) the details of assistance extended to support and promote handicrafts, State/UT-wise and scheme-wise;
- (c) whether there are any platforms/networks for artisans to connect and help each other and if so, the details thereof; and
- (d) the details of capacity building and/or support provided to handicraft artisans from Himachal Pradesh from 2018 till date?

#### **ANSWER**

### THE MINISTER OF STATE FOR TEXTILES (SMT. DARSHANA JARDOSH)

- (a): Office of Development Commissioner (Handicrafts) takes several steps to promote Indian handicrafts globally including crafts of Himachal Pradesh. It provides Grant-in-aid to eligible implementing agencies for organizing various international marketing events and also facilitates artisans to participate in important global marketing events. During the last three years, 105 international marketing events including Reverse buyer-seller meets have been organized benefitting 1,443 artisans/exporters.
- **(b):** The details of assistance extended by Office of Development Commissioner (Handicrafts) schemes to support and promote handicrafts State/UT-wise and scheme wise is enclosed at **Annexure.**
- (c): Ministry of Textiles under National Handicrafts Development Programme (NHDP) scheme provides the platform to artisans for discussion and interaction through various chaupals, workshops, study tours, small and big marketing events etc. and also connect and help each other.
- (d): Office of Development Commissioner (Handicrafts) provides support for capacity building through NHDP and Comprehensive Handicrafts Cluster Development Scheme (CHCDS). 15,670 artisans from Himachal Pradesh have benefited under their interventions from 2018 till date.
