**SCHEME FOR INTEGRATED TEXTILE PARKS**

3514. SHRI MOHAMMED NADIMUL HAQUE:

Will the Minister of TEXTILES be pleased to state:

- (a) the total number of Integrated Textile Parks (ITPs) set up in the country so far, State-wise details thereof;
- (b) the number of units in each ITP, ITP-wise;
- (c) whether it is a fact that the progress of Scheme for Integrated Textile Parks has been slow;
- (d) if so, the reasons therefor;
- (e) whether Government has taken any action to fasten the process of setting up the Textile Parks; and
- (f) if so, the details thereof and if not, the reasons therefor?

**ANSWER**

**(a) to (f):** With a view to increasing investments, generating employment opportunities and boosting exports in textile sector, a scheme viz. Scheme for Integrated Textile Park (SITP), to provide subsidy for setting up textile parks with world-class, state-of-the art infrastructure in textile hubs across the country is under implementation by the Government. Under SITP, a total of 54 Textile Parks have been approved by the Government in different parts of the country. 31 Textile Parks have been granted completion status, while remaining 23 Textile parks are at various stages of implementation. The State-wise details of Textile Parks with number of units are as Annexures. In order to have a regular monitoring of the progress of these Textile Parks, Project Management Consultants have been appointed by the Ministry. Apart from this, Regional Offices of Textile Commissioner are mandated to regularly visit the textile parks and submit monitoring and progress reports. An apex Project Approval Committee (PAC) headed by Secretary (Textiles) regularly monitors the progress of Textile Park under SITP.

Apart from this, the Government has approved setting up of 7 (Seven) PM Mega Integrated Textile Region and Apparel (PM MITRA) Parks in Greenfield/Brownfield sites with world class infrastructure including plug and play facility with an outlay of Rs. 4,445 cr for a period of seven years upto 2027-28. The Government has finalised 7 sites viz. Tamil Nadu (Virudhnagar), Telangana (Warangal), Gujarat (Navsari), Karnataka (Kalburgi), Madhya Pradesh (Dhar), Uttar Pradesh (Lucknow/Hardoi) and Maharashtra (Amrawati) for setting up PM MITRA Parks.
