STATUS OF URBAN DEVELOPMENT SCHEMES

NO. 3579. SHRI NEERAJ DANGI:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the current status of the schemes being run by Government for the urban poor;
- (b) the State-wise details of the amount allocated and spent, especially for Rajasthan, under the urban development scheme during the last three years; and
- (c) whether any monitoring mechanism was put in place to oversee the funds allocated by Government to the States during this period, if so, the details of action taken under such monitoring mechanism?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS

(a) to (c) The Ministry of Housing and Urban Affairs is implementing a Centrally Sponsored Scheme namely "Deendayal Antyodaya Yojana— National Urban Livelihoods Mission (DAY-NULM)", in the statutory towns of the country, including Rajasthan, to reduce poverty and vulnerability of urban poor households on a sustainable basis. Under its Employment through Skill Training and Placement (EST&P) component, skill training is provided to the urban poor candidates in market-oriented certified courses to place them in wage employment and/ or self-employment opportunities. In Social Mobilization and Institutional Development (SMI&D) component, a one-time Revolving Fund support of ₹ 10,000/- is provided to eligible Self Help Groups. Mission offers interest subvention at the rate over and above the rate of interest of 7% on the bank linkage loans sanctioned to Self Help Groups (SHGs). An additional 3% interest subvention is provided to women SHGs on timely repayment of loans. Under its Employment through Skill Training and Placement (EST&P) component, skill training is provided to the urban poor candidates in market-oriented certified courses to place them in wage employment and/ or self-employment opportunities.

In Self Employment Program (SEP) Component of the Mission, financial assistance to individuals/groups of Urban Poor for setting up gainful self employment ventures/micro enterprises, suited to their skills, training, aptitude and local conditions are also provided. Individual micro-enterprises and Group enterprises are eligible for Bank loans upto Rs. 2 lakhs and Rs. 10 lakhs respectively.SHGs under the Mission are facilitated for subsidized credit for undertaking gainful microenterprise activities. Additionally, active SHGs have also started their own enterprise with their saving corpus.A statement showing state-wise central fund released and utilized during the last three years under DAY-NULM is at Annexure-I.

Monitoring and review of utilization of funds allocated to the States/UTs under the Scheme is a continuous process and is carried out through institutional framework that consists of progress reports, field visits of senior officers and review through video conferences. Under DAY-NULM, there is a Governing Council (GC) at the National Level that reviews overall progress and development of the Mission. At the State level, the implementation is managed by a two-tier structure – a Governing Council and an Executive Committee. At the City level, DAY-NULM is managed by an Executive Committee chaired by the Municipal Commissioner.
