**REVENUE GENERATION IN MINING SECTOR**

3629. DR. SASMIT PATRA:

Will the Minister of MINES be pleased to state:

- (a) the total revenue through various categories raised and generated in the mining sector of the country since 2017 till date, State-wise, year-wise and category-wise;
- (b) the total revenue that was retained by the Centre, year-wise since 2017 till date; and
- (c) the total revenue that was provided to the States, year-wise and State-wise since 2017 till date?

**ANSWER**

(a) to (c): As per the Mines and Minerals (Development and Regulation) (MMDR) Act, 1957 and the Rules framed thereunder, the State Governments are empowered to grant mineral concessions for the minerals located within their respective jurisdiction. The revenue generated from mining activities viz. royalty, contribution to District Mineral Foundation (DMF), auction premium etc. accrues to the respective State Governments. However, only the contribution to the National Mineral Exploration Trust (NMET) accrues to the Central Government.

The information regarding revenue accrual to the State Governments from mining sector is not maintained centrally. As per the available information, the following is submitted:
