**EMPLOYMENT TO LOCAL PEOPLE AT (SAIL), ROURKELA**

3678 DR. SASMIT PATRA:

Will the Minister of STEEL be pleased to state:

- (a) details of how many local people from the region around Steel Authority of India Ltd. (SAIL), Rourkela have been appointed and/or employed by SAIL, Rourkela since 2017 till date in a year-wise, designation-wise and contractual/permanent nature of job wise format;
- (b) the number of local people employed/appointed by SAIL, Rourkela on the unfortunate demise of their parents or family members who used to work for SAIL, Rourkela; and
- (c) which section in the Employment Policy of SAIL, Rourkela provides for employment preference for local people?

**ANSWER**

- (a) 682 (Six hundred and eighty two) Nos. of local people from the region around Steel Authority of India Limited (SAIL), Rourkela i.e. from Odisha, have been appointed and /or employed by SAIL, Rourkela Steel Plant (including Odisha Group of Mines) since 2017 till 28.03.2023 against regular (permanent) posts. The details are placed at **Annexure 1**. As regards contract labours, they are appointed/employed by their employer i.e. contractor and details are not maintained by SAIL, RSP.
- (b) 23 (Twenty three) Nos. of local people have been employed/appointed by SAIL, Rourkela Steel Plant (including Odisha Group of Mines) on the unfortunate demise of their parents or family members who used to work for SAIL, Rourkela Steel Plant (including OGOM) since 2017.
- (c) There is no specific provision/section in SAIL Recruitment Policy & Recruitment Manual for providing preference in employment for local people.
