DIGITIZATION OF PANCHAYAT OFFICES

3739. SHRI IRANNA KADADI:

Will the Minister of PANCHAYATI RAJ be pleased to State:

- (a) the number and percentage of Panchayat Offices that have a computer and internet connection, State-wise;
- (b) the details of the steps taken by Government to digitize Panchayat Institutions and Offices;
- (c) the annual budget allocation and final expenditure on E-Panchayat Mission Mode Project during the last five years and the current year; and
- (d) the outcome status of the E-Panchayat Mission Mode Project?

ANSWER

THE MINISTER OF STATE FOR PANCHAYATI RAJ

- (a) Panchayat being State subject, providing computers for Panchayats is primarily the responsibility of States/ Union Territories (UTs). However, Ministry, under the scheme of Rashtriya Gram Swaraj Abhiyan (RGSA) supplemented the efforts of all States by providing computers for Panchayats as proposed by States/UTs in their Annual Action Plan and approved by Central Empowered Committee, on a limited scale. For attaining the vision of Digital India, BharatNet project is being implemented by Department of Telecommunications in a phased manner to create network to connect all the Gram Panchayats by broadband in the country. The scope of BharatNet on 30.06.2021 has been extended up to all inhabited villages beyond GPs in the country. The State/UT-wise details of Gram Panchayats/Traditional Local Bodies (TLBs) having computers and internet connection is given at **Annexure-I.**
- (b) Under Digital India Programme, Ministry is implementing e-Panchayat Mission Mode Project (MMP) with the aim to transform the functioning of Panchayati Raj Institutions (PRIs), making them more transparent, accountable, and effective. The Ministry launched eGramSwaraj, a work-based Accounting Application for Panchayati Raj Institutions under the e-Panchayat MMP on 24th April 2020. This application encompasses all aspects of Panchayat functioning viz. planning, budgeting, accounting, monitoring, asset management etc., on a single digital platform including online payments.

- (c) Funds under the e-Panchayat Mission Mode Project (MMP) are utilized for Central-level support for maintenance of e-Panchayat applications, faculty support and programme management. The year wise utilization of funds under the e-Panchayat MMP during the last five years and the current year is given at **Annexure-II.**
- (d) So far, 2.56 lakh GPs have prepared and uploaded their Gram Panchayat Development Plans (GPDPs) for 2022-23 on eGramSwaraj. Under 14th Finance Commission, 59,618 GPs have carried out online transactions during 2022-23. Similarly, 2.26 lakh GPs have carried online transactions under 15th Finance Commission during 2022-23. All States are making efforts to implement e-Panchayat MMP, based on their available resources and there is substantial improvement in adoption of digital applications by the States in PRIs functioning.
