POVERTY ALLEVIATION THROUGH RURAL DEVELOPMENT SCHEMES

3781. SHRI RAGHAV CHADHA:

Will the Minister of Rural Development be pleased to state:

- (a) the details of funds sanctioned/released to States particularly Punjab and utilised by them under various rural development and poverty alleviation schemes for last five years, scheme-wise and State-wise;
- (b) the achievements made during the said period under each scheme;
- (c) the number of people belonging to Scheduled Castes (SCs), Scheduled Tribes (STs) and Minority Communities benefited under each of these schemes; and
- (d) the steps taken by Government to ensure full utilisation of funds and completion of works in time?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT
(SADHVI NIRANJAN JYOTI)

(a) The Ministry of Rural Development is implementing a number of welfare schemes for rural areas of the country including the State of Punjab viz., Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS), Pradhan Mantri Awaas Yojana – Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY), Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM), Deen Dayal Upadhyay – Gramin Kaushalya Yojana (DDU-GKY), Rural Self Employment and Training Institutes (RSETIs), National Social Assistance Programme (NSAP), Shyama Prasad Mukherji Urban Mission (SPMRM) and Watershed Development Component (WDC) of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for rural development and poverty alleviation including the State of Punjab. State-wise details of the funds sanctioned/released and utilised including Punjab under these schemes during the last five years are at **Annexure**.

(b) During the last five years, under MGNREGS, 1519.38 Crore person-days generated. Under DAY-NRLM, 4056162 Self Help Groups (SHGs) formed, 43554216 households mobilized into SHGs, 4090239 Mahila Kishans covered and 203,649 enterprises supported under Start-up Vehicle Enterprise Programme. Under PMAY-G, 2.23 crore houses constructed. Under DDU-GKY, 946705 rural youth trained and 545,321 placed and under RSETI, 2152475 rural youth trained and 1631309 settled. Under SPMRM, out of the 300 clusters sanctioned, 291 clusters are at various stages of development. Under NSAP, 2,89,95,034 beneficiaries covered in 2017-18, 2,89,58,731 in 2018-19, 2,93,07,301 in 2019-20, 2,96,42,865 in 2020-21 and 2,98,67,336 in 2021-22. Similarly under WDC of PMKSY, 3, 96,198 Water Harvesting Structure created /rejuvenated, 21,66,176 Farmers benefitted and 3,88,66,423 mandays of employment generated during the said period.

(c) Under the above schemes, Scheduled Castes (SCs), Scheduled Tribes (STs) and minority communities, wherever applicable, are also getting the benefits. Under MGNREGS, 306.98 Crore SC and 273.04 crore ST persondays were generated. Under DAY-NRLM, from the Financial Year 2020-21 till 31.12.2022, 1,88,20,615 SC household, 1,15,79,886 ST households and 10,14,455 Minority households were brought under the ambit of the Scheme. As reported by States/UTs, a total of 67,88,713, 61,71,706 & 34,76,039 houses have been sanctioned to SC,

ST & Minorities under PMAY-G and 51,17,682, 45,76,425 & 29,05,517 houses have been completed under SC, STs & Minority respectively. Under DDU-GKY, 429349 SC rural youth trained and 233727 placed; 243612 ST rural youth trained and 151215 placed and 223344 minorities youth trained and 56158 placed. Under RSETI, 797711 SC rural youth trained and 577245 settled; 451110 ST rural youth trained and 319801 settled and 390509 minorities trained and 281496 settled. Under NSAP, there was no separate allocation and release of funds for ST beneficiaries before 2021-22. From 2021-22, ST beneficiaries were identified and separate allocation of funds for ST beneficiaries was made. Therefore, the no. of SC & ST beneficiaries under **NSAP** Schemes in 2021-22 and 2022-23 are as under:

PMGSY is not an individual/ community centric scheme. The roads constructed under PMGSY cater to all the strata of the society. Nevertheless, Scheduled Tribes Areas have got specific focus in the scheme by giving special dispensation. While eligibility criteria for other habitations for getting connectivity under the scheme is a population of 500 persons (as per 2001 census), for Tribal (Schedule V) areas and Selected Tribal and Backward Districts (as identified by the Ministry of Home Affairs and Planning Commission) and for North-Eastern and Himalayan States, unconnected habitations with a population of 250 persons and above (as per Census 2001) are eligible for providing all-weather road connectivity under the scheme.

So far as WDC of PMKSY is concerned, out of the total budget allocation 10% is released under Tribal Sub-Plan and 16.6% under Schedule Caste Sub-Plan. Since WDC-PMKSY is an rainfed/degraded area development programme, all the people including STs, SCs and minorities communities residing in project area are benefited.

(d) MoRD accords emphasis on proper implementation of all its rural development schemes. In order to ensure that the programme benefits reach the rural poor, the Ministry has evolved a comprehensive multi-level and multi-format system of monitoring and evaluation of the implementation of rural development programmes, including Performance Review Committee Meetings, District Development Co-ordination and Monitoring Committee (“DISHA”) meetings, National Level Monitors (NLMs), Area Officers Schemes, Common Review Mission, Concurrent Evaluation and Impact Assessment Studies. Social Audits are also conducted by some Schemes like Mahatma Gandhi NREGS and PMAY-G. Third-Party evaluation of the Schemes is also carried out regularly and actions, as appropriate, are taken on the findings. In addition to above, steps have also been taken to strengthen transparency and accountability using transaction based IT systems for MIS which include geo-tagging of assets, Direct Benefit Transfer (DBT), National electronic Fund Management System (Ne- FMS), Aadhaar Based Payment System (ABPS), Software for Estimate Calculation using Rural rates for Employment (SECURE) and establishment of independent social audit units and appointment of Ombudsman. State specific reviews of States/UTs are also undertaken from time to time.

7. National Social Assistance Programme (NSAP)

Under National Social Assistance Program (NSAP) scheme, the old aged, widows, and disabled persons belonging to Below Poverty Line (BPL) and fulfilling eligibility criteria prescribed in the NSAP guidelines, are provided financial assistance ranging from Rs.200/- to Rs.500/- p.m. and in the case of death of the breadwinner, a lumpsum assistance of Rs.20,000/- is given to the bereaved family.

It is primarily a social security scheme for the most vulnerable persons of our society living below poverty line, both in rural and urban areas.
