(a) to (d): The number of proposals received from Madhya Pradesh under District Disability Rehabilitation Centre (DDRC) and Assistance to Disabled Persons for Purchase/Fitting of Aids and Appliances (ADIP) schemes during the year 2021-22 and 2022-23 is as under:-

A statement indicating the details of number of proposals received from the State Government of Madhya Pradesh under District Disability Rehabilitation Centre (DDRC) and Assistance to Disabled Persons/Fitting of Aids and Appliances (ADIP) schemes during the year 2021-22 and 2022-23 is at **Annexure-I** and **Annexure-II** respectively.

Under the DDRC scheme, grant-in-aid is released in respect of the proposals which are complete in all respects as per the scheme guidelines. 5 proposals of the State Government of Madhya Pradesh in respect of DDRCs for the year 2021-22 have been approved so far. Remaining Proposals relating to DDRCs are not complete as per the scheme guidelines. The grant is released only after rectification of the deficiency, in consonance with the provisions of General Financial Rules.

8 proposals were received from Madhya Pradesh under the ADIP Scheme during 2021-22 and no proposal has been received during 2022-23. Funds have been sanctioned in respect of 4 proposals. Grant-in-aid is released in respect of the proposals which are complete in all respects.
