## PVTGs UNDER PRADHAN MANTRI DEVELOPMENT MISSION

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether it is a fact that the budget allocation for ParticularlyVulnerable Tribal Groups (PVTGs) under Pradhan Mantri PVTG Development Mission faces unique implementation challenge;
- (b) if so, the reasons therefor and the plan of action by the Union Government to resolve it; and
- (c) the amount of funds allocated and utilized for the tribal community under Special Central Assistance to Tribal Sub Scheme (SCA to TSS) from the year 2020, State-wise and year-wise?

## **ANSWER**

MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI BISHWESWAR TUDU)

(a), (b) & (c): Government has made an announcement in the Budget Speech 2023-24 for launching a Pradhan Mantri PVTG Development Mission to improve socio-economic conditions of the Particularly Vulnerable Tribal Groups (PVTGs), by saturating PVTG families and habitations with basic facilities such as safe housing, clean drinking water and sanitation, improved access to education, health and nutrition, road and telecom connectivity, and sustainable livelihood opportunities in association with the line Ministries concerned, State government/UT administration and NITI Ayog. Funds for implementation of this scheme have to be provided from out of the Development Action Plan for Scheduled Tribes (DAPST) grants of various Ministries/Department. The capacity building and awareness generation of all stake holders is an integral part of the strategy for effective implementation of the program. It further involve the state government for identification of the gaps and in implementation.
