# FINANCIAL ASSISTANCE TO ARTISANS

#### 438. SHRI DHANANJAY BHIMRAO MAHADIK:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

(a) whether Ministry provides financial assistance to artisans to construct workshed and if so, the details thereof;

(b) the number of khadi and other artisans benefited under the workshed scheme in Maharashtra during each of last five years and the current year;

(c) the total number of khadi artisans who were provided assistance for construction of worksheds in Maharashtra and Rajasthan under the scheme during last five years and current year; and

(d) whether there is great boost to the sale of khadi products during each of the last three years and if so, the States which have contributed to the sale of khadi products?

## ANSWER

## MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

(a): Yes Sir. Ministry of MSME, through Khadi and Village Industries Commission (KVIC), provides financial assistance to artisans to construct workshed under 'Workshed Scheme for Khadi Artisans'. For construction of Individual Workshed, an assistance up to Rs 80,000/- or 75% of the cost (90% for NER) and for Group Workshed, an assistance up Rs. 1,20,000/- or 75% of the cost (90% for NER), whichever is less, is provided.

(b)&(c): Number of Khadi artisans benefitted and financial assistance provided under the Workshed Scheme in Maharashtra and Rajasthan during last five years and the current year is as follows:
