Shell Companies in the country

523# Shri Satish Chandra Dubey:

Will the Minister of Corporate Affairs be pleased to state:

(a) the total number of companies identified as Shell companies during last three years, especially in Bihar as well as in other States, the details thereof;

(b) whether any Committee has been constituted to look into the issues related to the said companies and to monitor the progress of action taken against them;

(c) if so, the number of such companies as well as their promoters against whom action has been taken so far; and

(d) the steps taken by Government to identify other such companies and the measures taken to prevent such incidents?

ANSWER

(a) & (b) : The term "Shell Companies" is not defined in the Companies Act, 2013. However, in terms of Section 248(1) of the Companies Act, 2013 read with the Companies (Removal of Names of Companies from the Register of Companies) Rules, 2016 (amended Rules 2019) names of certain companies have been struck off for certain violations such as failing to commence business within one year of incorporation, not carrying on any business or operation for a period of two immediately preceding financial years and not making any application within such period for obtaining the status of a dormant company, not carrying on any business or operations, as revealed after the physical verification etc. A total of 1,27,952 names have been (3,872 companies from the State of Bihar) removed by the Registrar of Companies from the register during the financial years 2019-20, 2020-21 & 2021-22. Details are given here under: -

The above-mentioned number of companies have been struck off by the concerned Registrars. No committee has been constituted for this purpose.

(c) Consequent upon action initiated under section 248(1) of the Companies Act, 2013, directors have incurred disqualification in terms of the provision of Section 164(2)(a) r/w 167 of the Companies Act, 2013 for filing of Annual Return or Balance Sheet for continuous period of three financial Years in earlier three Drives. Details are as under: -

(d) MCA has implemented filing of directors KYC in e-form DIR-3 wherein all the KYC details/data of each director is captured. Further, for the location of the Registered Office of the Company Form INC-22 is mandated. Further, power has been delegated to the Registrar of companies for physical verification of registered office of the companies from time to time to verify the status of the companies registered with the MCA.
