- (a) The total funds transfer from Centre to States since 2017, year-wise, State-wise and category-wise/item-wise; and
- (b) The reasons for increase or decrease in transfer of funds from Centre to States, category-wise/item-wise?

(a): The Union Government provides resources to States through Ministries/Departments under the heads Tax Devolution, Finance Commission Transfers, Centrally Sponsored Schemes (CSS), Central Sector Schemes (CS), Additional Central Assistance (ACA) for Externally Aided Projects (EAPs), Special Assistance etc. Summarized details of 'Transfers to States' during the last five years 2017-18 to 2022-23 are as follows:

The Year-wise and State-wise details of transfers to States under various heads by the Ministry of Finance since 2017-18 are provided in Annexure.

**(b):** The allocation/release of tax devolution to States has increased from 2017-18 to 2022-23 primarily due to higher accumulation of resources in the divisible pool of taxes and duties. Similarly, allocation/release of Finance Commission Transfers have increased from 2017-18 to 2022-23 due to implementation of recommendations of the 14<sup>th</sup> Finance Commission and the 15<sup>th</sup> Finance Commission. Further, transfers to States under Centrally Sponsored Schemes/Central Sector Schemes have increased due to higher allocation of funds under the Schemes/Programme by the Union Governments.
