HEALTH INFRASTRUCTURE

579. SHRI HARBHAJAN SINGH:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) Whether the Government has received proposals from the States regarding financial assistance for improving the infrastructural and other facilities in their respective Government hospitals;
- (b) If so, the details thereof during the last three years, State/UT-wise including Punjab, along with the action taken thereon;
- (c) Whether the Government proposes to allocate more funds to the States for this purpose; and
- (d) If so, the details thereof, if not, the reasons therefor?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (d): Under National Health Mission (NHM), technical and financial support is provided to States/UTs for strengthening of healthcare systems based on the proposals submitted by States/UTs in Program Implementation Plans (PIPs). Proposals are reviewed by Government of India during the National Programme Coordination Committee (NPCC) meeting which is jointly attended by both the State and Central officials and approvals are accorded in the form of Record of Proceedings (RoPs) as per norms & available resources.

The details of PIPs and RoPs for the last three years for all States/UTs are available at website of National Health Mission i.e. https://nhm.gov.in.

Details of financial assistance provided during the last three years to the States/UTs (including Punjab) for the activity of hospital strengthening and new constructions/renovation / setting up is as per **Annexure-I.**

Further, **PM-Ayushman Bharat Health Infrastructure Mission** (PM-ABHIM) was launched with an outlay of Rs. 64,180 Cr for the period of 2021-22 to 2025-26. The measures under PM-ABHIM focus on developing capacities of health systems across the continuum of care at all the levels, primary, secondary and tertiary to prepare health systems in responding

effectively to the current and future pandemics/disasters. The scheme is a Centrally Sponsored Scheme with some Central Sector Components

15th Finance Commission (FC-XV): Government of India is supporting rural and urban local bodies through the 15th Finance Commission for addressing the gaps in Primary Healthcare facilities. Funds to the tune of Rs. 70,051 Cr have been allocated for the period from 2021-22 to 2025-26.

Medical Colleges: The Ministry of Health & Family Welfare is implementing Centrally Sponsored Scheme (CSS) for 'Establishment of new Medical Colleges attached with existing district/referral hospitals' with preference to underserved areas and aspirational districts, where there is no existing Government or private medical college.

Under **Pradhan Mantri Swasthya Suraksha Yojana** (**PMSSY**), Union Cabinet has approved setting up of 22 All India Institute of Medical Science (AIIMS). A total of 75 projects have been approved for upgradation of Government Medical Colleges/Institutions (GMCIs) for setting of Super Speciality Block (SSB) and/or Trauma Centre.
