DETAILS OF NATIONAL HIGHWAYS IN THE COUNTRY

742. DR. SASMIT PATRA:

Will the Minister of **ROAD TRANSPORT AND HIGHWAYS** be pleased to state:

- (a) details of total length of National Highways completed during last five years in a State-wise and year-wise format;
- (b) total funds spent by the Ministry for the above in last five years in a State-wise and year-wise format; and
- (c) total length of National Highway to be completed in next two years and funds allocated for it State-wise?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

(SHRI NITIN JAIRAM GADKARI)

- (a) Ministry has constructed 60479 km of National Highways during last five years and current year. Details are given in Annexure-I.
- (b) & (c) Allocation of funds takes place during each financial year. State / UT wise details of funds allocated and the expenditure incurred, for development of National Highways, in last five years and the current year is given in Annexure-II. Apart from this, year wise details of funds allocated and expenditure incurred / funds released under other Schemes / Agencies for development of NHs during the last five years and current year are placed at Annexure-III.

Development of National Highways (NHs) is a continuous process and works are taken up based on traffic density, connectivity requirements, inter-se priority and availability of funds. As a part of this ongoing development process, Ministry envisaged to construct about 60,000 Km of National Highways during the five year period from 2019-20 to 2023-24, and have set targets on year to year basis. The target set for current year 2022-23 is 12200 km. For the year 2023-24, Ministry envisages to construct 13000 km, but targets have not been finalized.
