#### 754 SHRI RAGHAV CHADHA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of the average mandays under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) in the past five years both at National level and State-wise:
- (b) whether there is any proposal of Government to increase the number of eligible work days under MGNREGA, if so, the details thereof;
- (c) whether Government has sanctioned any special funds for the districts of Punjab to mitigate and solve the important local needs of the people, if so, the details thereof; and
- (d) the total funds allocated, disbursed to the State of Punjab during the last five years under MGNREGS?

#### **ANSWER**

### MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a): State/UT-wise and National level details of average days of employment provided per households under Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) in the last five financial years 2017-18, 2018-19, 1019-20, 2020-21 and 2021-22 are given at **Annexure.**

(c)&(d): Mahatma Gandhi NREGS is a demand driven wage employment Scheme. There is no State/UT-wise allocation of funds under Mahatma Gandhi NREGS.

Under Mahatma Gandhi NREGS, release of funds to States/UTs is a continuous process and Central Government is committed to making funds available to States/UTs for the implementation of Scheme as per demand for work on the ground.
