(a) No financial assistance to industrial units or individuals is provided under Skill Acquisition and Knowledge Awareness for Livelihood Promotion (SANKALP) project. The objectives of SANKALP are to strengthen the short term skill ecosystem and to address the challenges like bringing about convergence, infusing quality in skill development programmes and making them market relevant and accessible in the context of short-term skill training. These objectives are met through its three key result areas namely (i) Institutional Strengthening at Central, State and District level; (ii) Quality Assurance of skill development programmes; and (iii) Inclusion of marginalized population in skill development programmes.

(b) SANKALP focuses upon projects in line with its Result Areas as stated above. Details of some of the skill acquisition training programmes provided under national component of SANKALP, the benefits of which include strengthening capacity of Trainers/ Assessors, Certifying/ Upskilling skills of the existing workforce, increased participation of women and other marginalized groups in skill and entrepreneurship training etc is placed at *Annexure I*.
