PLACEMENTS UNDER PMKVY 3.0

768. SHRI MUZIBULLA KHAN:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) placement target under the Pradhan Mantri Kaushal Vikas Yojana Phase 3 (PMKVY 3.0), State-wise, for the last three years;
- (b) the placement percentage attained across the country at an aggregate and State level specifically under the PMKVY 3.0 in the year 2021, and 2022;
- (c) whether PMKVY 3.0 has achieved the set targets for imparting quality skills; and
- (d) if so, the details thereof and, if not, the reasons therefor?

ANSWER

(a) Ministry of Skill Development and Entrepreneurship (MSDE) has launched the Pradhan Mantri Kaushal Vikas Yojana (PMKVY 3.0) on 15.01.2021 with an objective to deliver skills to youth of the country to make them employable for better livelihood. PMKVY scheme is demand driven scheme. Ministry through various initiatives has facilitated the placement of the short term certified candidates.

(b) Under PMKVY 3.0, training have been imparted through Short Term Training (STT), Recognition of Prior Learning (RPL), Customized Crash Course Programme for COVID Warriors and Skill Hubs Initiative. Under PMKVY 3.0, placement opportunities were facilitates to STT certified candidates. As on 31.12.2022, under STT component (excluding Customized Crash Course Programme for COVID Warriors and Skill Hubs Initiative) of PMKVY 3.0, 1.14 lakh candidates have been certified; out of which, 32,597 candidates have been reported placed. The State wise details of candidates certified and reported placed under STT component of PMKVY 3.0 as on 31.12.2022 are placed at **Annexure**.

(c) and (d) Under PMKVY 3.0, 7.37 lakh candidates have been imparted skill training. Stringent Quality parameters were followed in PMKVY 3.0 while conducting the skill Training. Under PMKVY, training has been imparted in National Skill Qualification Framework aligned courses only. To ensure the quality in skill training, training was imparted and assessment was done through certified trainer and assessor only. Monitoring and supervision was done at various levels to ensure quality outcomes.
