**INADEQUATE RESERVATION TO OBC**

776. DR. ANBUMANI RAMADOSS

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:-

- (a) whether the Union Government is aware that Other Backward Classes (OBCs) are inadequately represented (less than 27 per cent) in both Central Government employment and Central Educational Institutions;
- (b) if so the details thereof;
- (c) whether the Union Government will review the Central Reservation Policy as the OBCs are not proportionally represented (inadequate) to their population both in Central Government Employment & Central Educational Institutions; and
- (d) if so, the details thereof and reasons therefor?

- (a) & (b) As per information received from the concerned Departments, the table showing the representation of SC/ST/OBC in Central Government since 2014-2021 is at **Annexure-I** and the table showing social group wise enrollment in Higher Education since 2014-15 is at **Annexure-II**. It is seen that the representation of OBC against total appointment made through direct recruitment has been consistently above 27% during this period and the enrollment of OBCs in Higher Educational Institutions has been consistently increasing since 2014-15.
- (c) & (d) There is no proposal to review the existing reservation scheme.
