PLI SCHEME FOR MOBILE MANUFACTURING COMPANIES

***180. DR. V. SIVADASAN:**

Will the Minister of Electronics and Information Technology be pleased to state:

- (a) the list of companies that had applied for incentives under the Production Linked Incentive (PLI) scheme for large scale mobile and component manufacturing and list of companies which have achieved their targets and those which have failed to achieve their targets, the details thereof since 2021, year-wise;
- (b) whether Government has noted any attempt by companies to claim incentives by inflating invoices;
- (c) the details of production and amount paid out to each company, since 2021, year-wise; and
- (d) whether any payments are pending for any company despite targets being achieved, if so, the details thereof?

(a): Government of India's goal is to broaden and deepen the country's electronic manufacturing ecosystem as well as increase India's participation in electronics Global Value Chains (GVCs). To boost domestic manufacturing and attract investment in mobile phones value chain including electronic components and semiconductor packaging, Production Linked Incentive Scheme (PLI) for Large Scale Electronics Manufacturing was notified on 01.04.2020. The scheme extends an incentive of 3% to 6% on incremental sales (over base year) of goods manufactured in India and covered under target segments viz. Mobile Phones and specified Electronic Components, to eligible companies, for a period of 5 years. During the scheme tenure, the scheme is expected to contribute investment of INR 7,000 crore, production of INR 8,12,550 crore, exports of INR 4,87,530 crore and generated employment of 2,00,000 (direct jobs).

32 applicants are approved under the Scheme. 16 companies were approved in Round 1 (10 companies for Mobile Phone and 6 companies for Specified Electronic Components), and 16 companies were approved in Round 2 for Specified Electronic Components. In order to provide relief to companies approved under the PLI Scheme affected by the COVID-19 pandemic, the tenure of the PLI Scheme has been extended by one year i.e., from 2024-25 to 2025-26. From Round 1, 15 out of 16 applicants have opted for extension, and from Round 2, 9 out of 16 applicants have opted for extension.

(b): Prior to disbursement of incentive, Project Management Agency (PMA) uses the Standard Operating Procedure (SoP) for pricing of Target Segment goods. In case of transaction with non-related parties, PMA relies upon Auditor's Certificate, trial balance and sales register provided by the Company and places reliance on the transaction value recorded in the books of accounts. In case of transaction with related parties, transaction value should be in alignment with the transfer pricing reporting under Income Tax Act, 1961 wherever applicable.

For all the disbursements under the PLI Scheme for LSEM so far, PMA has followed the above approach and has not reported any attempts by the companies for inflated invoices to claim incentives.
