- (a) the details of plan of expenditure of ₹89,047 crore allocated to BSNL as revival package;
- (b) the details of amount that was released for earlier revival packages, year-wise;
- (c) in what manner BSNL has been benefitted from the earlier packages;
- (d) the number of employees who have opted for Voluntary Retirement Scheme (VRS) and the amount spent on VRS;
- (e) whether BSNL will be able to launch 5G services by 2023, if so, timeline thereof, Statewise; and
- (f) in what manner BSNL will reduce its debt, the details thereof?

(a) The details of plan of expenditure of ₹89,047 crore allocated to Bharat Sanchar Nigam Limited (BSNL) as revival package is given below:

(b) & (c) To transform BSNL into a viable Public Sector Undertaking (PSU), the Cabinet on 23.10.2019, 27.07.2022 and 07.06.2023 approved revival packages to BSNL and MTNL. The revival measures mainly focus on rationalization of manpower cost through Voluntary Retirement Scheme (VRS) supported by budgetary allocation by Government of India for ex-gratia, debt restructuring by raising of Sovereign Guarantee Bonds, administrative allotment of spectrum for 4G services,

infusing fresh capital for upgrading BSNL services, allocation of spectrum, de-stressing the Balance Sheet and augmentation of Fibre network by merging Bharat Broadband Network Limited (BBNL) with BSNL.

The details of amount released for earlier revival packages, year-wise is given below:

- (d) Total 78,323 employees retired voluntarily under BSNL Voluntary Retirement Scheme (VRS)-2019 and an amount of ₹13,542.05 Crore released to BSNL for payment of Ex-gratia to VRS retirees.
- (e) In line with Atmanirbhar initiative of the Government, BSNL has issued Purchase orders for one-lakh 4G sites to rollout 4G services all over India within 18 to 24 months. BSNL is planning 5G services after rollout of 4G services across the country.
