PMFME SCHEME

Will the MINISTER OF **FOOD PROCESSING INDUSTRIES** be pleased to state:

- (a) whether Government is taking several steps to formalise micro food processing enterprises in the country;
- (b) the details of the activities undertaken, and funds utilized during last three years, in order to achieve the said objective; year-wise, State-wise; and
- (c) the details of the number of enterprises who have been formalised under the Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) scheme during last three years, year-wise, State-wise?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

- (a): Ministry of Food Processing Industries (MoFPI) is extending credit linked subsidy to the interested individual/entity for upgradation of existing or setting up of new micro-food processing facility, in accordance with the guidelines of Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME) scheme.
- (b): Establishment of Common Infrastructure projects by FPOs/SHGs/Cooperatives/Govt. Entities; Seed Capital to SHG members; Marketing & Branding projects for ODOP; and Capacity Building through training institutions are also supported as per the PMFME scheme.

Rs.984.966 crores has been released to the State/UTs towards implementation of various activities under the scheme till 15th July 2023 as per details given at **Annexure-I**.

(c): 4,300 enterprises have been formalised under PMFME Scheme during the last three years till 15th July 2023 as per details given at **Annexure-II**.
