WORK PROGRESS IN BBMP-BENGALURU UNDER AMRUT SCHEME

NO. 1168. SHRI NARAYANA KORAGAPPA:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether 3 projects for water supply, 13 projects for sewage and septage management and 10 projects for development of parks have been sanctioned for Bruhat Bengaluru Mahanagar Palike (BBMP) in Karnataka under AMRUT Scheme with an estimated cost of Rs. 992 crores;
- (b) if so, details thereof;
- (c) present status of the projects; and
- (d) whether there is any delay and, if so, by when they are likely to be completed?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

- (a) to (c): Yes, Sir. Under Atal Mission for Rejuvenation Urban Transformation (AMRUT), 03 projects for water supply, 13 projects for sewage and septage management and 10 projects for park development have been sanctioned for Bruhat Bengaluru Mahanagara Palike (BBMP) in Karnataka with an estimated cost of ₹992 crore. Present status of the above projects is at ANNEXURE.
- (d): There is no substantial delay in Water Supply and Sewerage & Septage Management projects. As informed by the State Government, Water Supply project is already physically completed on ground; Sewerage & Septage management project is estimated to be completed by 31st July 2023; and regarding the park projects, 8 projects out of 9 are completed and one park project is delayed due to change of location of the park site, project is estimated to be completed by 1st week of March 2024.
