CSR SPENDING BY PSUs AND PRIVATE SECTOR UNITS IN PUNJAB

QUESTION

1314. SHRI VIKRAMJIT SINGH SAHNEY:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

(a) the aggregate spending in the last five years by the Public Sector Units (PSUs) and private sector units on Corporate Social Responsibility (CSR) in Punjab, district-wise and public and private sector unit-wise and year-wise;

(b) whether Government has any check and monitoring system to examine that the CSR funds were spent genuinely for the said purpose and the details thereof; and

(c) the details of the projects undertaken by CSR spending in Punjab by various PSUs and private sector units, project-wise, public and private sector unit-wise?

(a) : The broad framework for Corporate Social Responsibility (CSR) has been provided under Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. All data related to CSR filed by companies in MCA21 registry is available in public domain and can be accessed at <u>www.csr.gov.in</u>. On the basis of annual filings made by Companies in the MCA21 registry, the aggregate CSR spent by Public Sector Undertakings (PSUs) and Non-PSUs in Punjab during the last five financial years (FY) 2017-18 to 2021-22 are given below:

(b): The CSR framework is disclosure based and CSR mandated companies are required to file details of CSR activities annually in the MCA21 registry. The corporate governance framework along with the existing legal provisions such as mandatory disclosures, accountability of the CSR Committee and the Board, provisions for statutory audit of accounts of the company etc. provide safeguards in this regard. Whenever

any violation of CSR provisions is reported, action against such non-compliant companies are initiated as per provisions of the Companies Act, 2013 after due examination of records and following due process of law. Further, the amendments in the Companies (CSR Policy) Rules, 2014 notified on 22nd January 2021 have strengthened the CSR eco-system by bringing more objectivity, transparency, entrusting more responsibility on the Board and enlarging the disclosures by the companies.

(c): Development Sector-wise details of CSR spent by PSUs and Non-PSUs in the state of Punjab during FY 2017-18 to 2021-22 is at Annexure – II. Further, the project-wise details of CSR spent by the Companies is not maintained separately by the Ministry.
