QUESTION

1316 DR. KIRODI LAL MEENA:

Will the Minister of Corporate Affairs be pleased to state:

- (a) the details of PSUs/companies functioning under each Ministry and the details of profits earned/ losses made by each of them during the last five financial years;
- (b) whether Government has the details of percentage of profit spent on Corporate Social Responsibility (CSR) by each of them during the said period, if so, the details thereof and if not, the reasons therefor; and
- (c) whether Government has the details of percentage of profit spent on CSR by India's multinational conglomerate companies during the said period, if so, the details thereof and if not, the reasons therefor?

- (a) & (b): As per inputs provided by Department of Public Enterprises (DPE), Ministry of Finance, the list of Central Public Sector enterprises (CPSEs) along with profit/loss and CSR expenditure during 2017-18 to 2021-22 is available in public domain on DPE website. The link for accessing the said details is at Annexure.
- (c): The Corporate Social Responsibility ('CSR') framework is disclosure based and CSR mandated companies are required to file details of CSR activities annually in the MCA21 registry. All data related to CSR filed by companies in MCA21 registry is available in public domain at www.csr.gov.in. In the Companies Act, the word 'multinational conglomerate companies' has not been defined. However, on the basis of the filings made by each companies in the MCA 21 registry, details of CSR funds spent by all companies, in different States/Union Territories (UTs) for the Financial Year (FY) 2017-18 to 2021-22 is given below:
