SPECIAL FINANCIAL ASSISTANCE PROVIDED TO VARIOUS STATES FOR CAPITAL INVESTMENT

Will the Minister of FINANCE be pleased to state:

- (a) the quantum of special financial assistance provided to various states for capital investment and the relative capital investment made by those states during the financial years 2020-21, 2021-22 and 2022-23, the details thereof, state-wise; and
- (b) the plan being devised by the Government to increase the investment of states having less capital investment?

ANSWER

THE MINISTER OF STATE FOR FINANCE (SHRI PANKAJ CHAUDHARY)

(a): The details of special financial assistance as 50-year interest free loan released to the States under the Schemes for Special Assistance to States for Capital Expenditure for 2020-21 and 2021-22 and Scheme for Special Assistance to States for Capital Investment for 2022-23 and the relative capital investment made by the States are provided in Annexure.

(b): Scheme guidelines on the Scheme for Special Assistance to States for Capital Investment 2023-24, inter-alia, provide that funds under Part-1 of the scheme will be released to States in two installments. The 1st installment of 66.67% of the approved amount will be released to the State Government on meeting the prescribed conditions and on approval of capital expenditure on the capital projects posed by the State. The 2nd installment of 33.33% will be released on submission of utilization certificates of at least 75 percent of the amount released as the 1st installment and on meeting prescribed mandatory conditions including achievement of target fixed for the State for total capital expenditure for the year 2023-24.
