AB-PMJAY IN TRIPURA

1374. SHRI BIPLAB KUMAR DEB:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

(a) whether Government is implementing the largest public funded health protection scheme in the world;

(b) if so, the details thereof, State-wise including district-wise for Tripura; and

(c) the details of the eligible beneficiaries under the scheme, State-wise including district-wise for the state of Tripura?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (PROF. S. P. SINGH BAGHEL)

(a) to (c): Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) is the largest publicly funded health protection scheme in the world which aims to provide health cover of Rs. 5 lakh per family per year for secondary and tertiary care hospitalization to 12 crore families. Many States/UTs implementing AB-PMJAY have expanded the beneficiary base to approximately 15.5 crore families at their own cost. The scheme is implemented in 33 States/UTs except for Delhi, Odisha, and West Bengal.

As on 25th July 2023, approximately 24.19 crore Ayushman cards are created and a total of 5.38 crore hospital admissions worth Rs. 66,039 crore are authorized under the scheme. State/UT-wise details of the number of eligible beneficiary families are at **Annexure-I**.

In the State of Tripura, as on 25th July 2023, 13.34 lakh Ayushman cards are created and 2.42 lakh hospital admissions worth Rs. 211.1 crore are authorized under the scheme in the State of Tripura. District-wise details of the number of eligible beneficiary families in the State of Tripura are at **Annexure-II**.
