CENTRALLY SPONSORED SCHEMES IN RURAL AREAS

1444 Shri Neeraj Shekhar:

Will the Minister of *Education* be pleased to state:

- (a) the details of Centrally Sponsored Schemes/programmes being run by Government for primary education in rural areas of the country; and
- (b) the details of fund allocated, released and utilised for primary education in rural areas of the country during 2022-23 and 2023-24 till date, year-wise, State-wise and scheme-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SMT. ANNPURNA DEVI)

(a) to (b): Education is in the Concurrent List of the Constitution and majority of the schools fall under the domain of the respective State/UT Government - the appropriate Government under the Right of Children to Free and Compulsory Education (RTE) Act, 2009.

The Department of School Education and Literacy is implementing an integrated centrally sponsored scheme for School education- Samagra Shiksha. The scheme provides support for the implementation of the RTE Act and has now been aligned with the recommendations of the National Education Policy (NEP) 2020. It aims to ensure that all children have access to quality education with an equitable and inclusive classroom environment which should take care of their diverse background, multilingual needs, different academic abilities and make them active participants in the learning process.

Under the Scheme, financial assistance is provided to the States and UTs for providing equitable and qualitative education including primary education in rural areas, to implement various interventions including up-gradation and running of Kasturba Gandhi Balika Vidyalayas, setting up of Netaji Subhash Chandra Bose Avasiya Vidyalayas, free uniforms to eligible children and free text books at elementary level, transport allowance and undertaking enrolment & retention drives. Further, special training for age appropriate admission of out of school children and residential as well as non-residential training for older children, seasonal hostels / residential camps, special training centres at worksites, transport/ escort facility are also supported to bring out of school children to the formal schooling system. The norms for

special training is ₹ 6000/- per child per annum for non-residential training and ₹ 20,000/- per child per annum for residential training.

Under Samagra Shiksha, financial assistance is provided to the States/UTs on the basis of their respective Annual Work Plan and Budget (AWP&B) Proposals. These plans are then appraised, estimated and approved by the Project Approval Board of this Department in consultation with the States and UTs as per the programmatic and financial norms of the scheme. Further, the funds are released on the basis of physical and financial progress of the interventions approved earlier, submission of Audited Accounts, Utilization Certificate, physical and financial progress and other documents as prescribed under the Financial Management & Procurement (FMP) Manual of Samagra Shiksha. The State-wise details of Proposed Central Release, Central Release and Expenditure for Elementary Education, Samagra Shiksha during 2022-23 and 2023-24 is at Annexure I (Data is not maintained separately for Primary Education (class 1-5).

Government has approved the proposal for continuation, revision and modification of the Centrally Sponsored Scheme Mid-Day Meal Scheme in 2021-22 and renamed it as 'Pradhan Mantri Poshan Shakti Nirman (PM POSHAN) for providing one hot cooked meal to eligible children in Government and Government – aided Schools at the elementary level of education, including Balvatika. The main objectives of the PM POSHAN Scheme are to address two of the pressing problems for majority of children in India, viz. hunger and education by improving the nutritional status of eligible children in Government and Government-aided schools as well as encouraging poor children, belonging to disadvantaged sections, to attend school more regularly and help them concentrate on classroom activities. The funds allocated/released (for Elementary Education) under the scheme during 2022-23 and 2023-24 are at Annexure II (Data is not maintained separately for Primary Education (class 1-5).

The Right of Children to Free and Compulsory Education (RTE) Act, 2009, mandates the respective State and Union Territory Government- which are the appropriate Government, to provide free and compulsory elementary education to every child of the age 6 to 14 years in a neighbourhood school.
