COMPLIANCE OF PRADHAN MANTRI AWAAS YOJANA (GRAMIN) IN KERALA

1552 DR. RADHA MOHAN DAS AGRAWAL:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of the achievements made with regard to the scheme PMAY-G in different States of the country in proportion to their population;
- (b) whether Government of Kerala has made any changes in the nature of the scheme, if so, the details thereof;
- (c) whether the sentence "Pradhan Mantri Awaas Yojana se Nirmit Awaas" has been displayed on the houses constructed under the scheme; and
- (d) the details of the achievements made with regard to the scheme in different constituencies of Kerala?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a): The Ministry of Rural Development is implementing Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) with effect from 1st April, 2016 to provide assistance to eligible rural households for construction of 2.95 crore Pucca houses with basic amenities by March, 2024 to achieve the objective of "Housing for All" in rural areas. Under PMAY-G, the beneficiaries have been identified based on the housing deprivation parameters prescribed under Socio Economic Caste Census (SECC) 2011 database and finalised Awaas+ list and not in proportion of their population. The State/Union Territory (UT) wise details of targets allocated by the Ministry, houses sanctioned to eligible beneficiaries by the States/UTs and houses completed as on 27.07.2023 is given in **Annexure-I**.
- (b): No sir.
- (c): To ensure uniformity and ease in identification, the Ministry has issued guidelines regarding display of following details on the wall of the completed PMAY-G houses:
 - i. Official Logo of PMAY-G
 - ii. Name of the beneficiary
 - iii. Name of Father/ husband
 - iv. Category
 - v. Year of Sanction
 - vi. Name of the village/ Block/ District
 - vii. Amount spent (a) assistance received, (b) self resources, (c) Total
- (d): The Ministry allocates the targets to the State/UT as a whole and district-wise targets are fixed by the State/UT. The District-wise details of houses sanctioned & completed under PMAY-G in Kerala is given in **Annexure-II**.
