**ASSISTANCE TO STATES FOR TRAINING IN SKILL DEVELOPMENT**

#1565. SHRI DEEPAK PRAKASH:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the manner in which Government is assisting the States to create better infrastructure to help the youths in getting meaningful training in skill development;
- (b) the number of categories and subjects of skill development which have been identified; and
- (c) the names of the Ministries through which Government is coordinating the skill development programme, Ministry-wise details thereof?

**ANSWER**

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI RAJEEV CHANDRASEKHAR)

(a) The Skill India Mission (SIM) of the Govt of India is aimed at Skilling, Re-skilling and Up-skilling to ensure our youth are prepared for the large number of opportunities coming up as the economy expands and India moves from the 10<sup>th</sup> largest economy to 3<sup>rd</sup> largest economy in the world. SIM is aimed at future ready and Industry ready talent among the youths.

Under SIM, Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill training to all sections of the society across the country, through a comprehensive network of skill development centres/ institutes under various schemes viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Sikhshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs).

Setting up of it is and their upgradation/ modernization are the responsibility of the State Governments/ UT Administrations. However, the Central Government is implementing following schemes under which financial assistance is provided to the State Governments/ UT Administrations for setting up and upgradation of their Industrial Training Institutes (ITIs):

- i. Upgradation of existing Government ITIs into Model ITIs
- ii. Enhancing Skill Development Infrastructure in North Eastern States
- iii. Skill Development in 48 Districts affected by Left Wing Extremism (LWE)
- iv. World Bank assisted Skills Strengthening for Industrial Value Enhancement (STRIVE) project

MSDE is implementing another World Bank assisted Skill Acquisition and Knowledge Awareness for Livelihood Promotion (SANKALP) project, one of the key result areas of which is Institutional Strengthening at Central, State and District level under which Financial assistance is being given to the State Governments/ UT Administrations.

(b) Under PMKVY, the skill training is being given in 37 broad sectors, in JSS, 11 sectors and in CTS, 33 Sectors.

(c) Besides MSDE, there are 20 Ministries/ Departments of Central Government which are implementing the skill development programme, the list of which alongwith schemes being implemented is at **Annexure-I**.
