BUDGETARY ALLOCATION FOR ELIMINATION OF MANUAL SCAVENGING

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:-

- (a) the budgetary allocation in the last five years to eliminate manual scavenging;
- (b) whether the Self Employment Scheme for Rehabilitation of Manual Scavengers has been removed from the budget for the year 2023-24;
- (c) whether an alternative or replacement scheme been proposed to ensure the continued rehabilitation and empowerment of Manual Scavengers;
- (d) number of deaths of worker occurred while cleaning of sewer during last five years, State/UT-wise and year-wise; and
- (e) number of cleaning workers who have been assisted by Swacchta Udyami Yojana (SUY) since the inception of the scheme, State/UT-wise?

- (b) & (c) The nomenclature of the SRMS Scheme has been changed to "National Action for Mechanised Sanitation Ecosystem" (NAMASTE) and existing components of Self Employment Scheme for Rehabilitation of Manual Scavengers (SRMS) have been kept as component of NAMASTE Scheme to ensure rehabilitation of manual scavengers.
- (d) Number of deaths occurred in State/UTs due to hazardous cleaning of sewers and septic tanks during last five years and current year are enclosed in Annexure-I.
- (e) National Safai Karamcharis Finance and Development Corporation (NSKFDC) has released loans of Rs 86.84 Crore to the State Channelizing Agencies (SCAs) for procurement of mechanized cleaning equipments/ vehicles to 2509 number of beneficiaries under Swachhta Udyami Yojana (SUY) as on 30.06.2023.
