#### 'SWADHAR GREH SCHEME' FOR REHABILITATION OF WOMEN'

#### 1585 SHRI SANJAY RAUT:

Will the Minister of Women and Child Development be pleased to state:

- (a) whether Government has launched Swadhar Greh Scheme for helping women victims of difficult circumstances;
- (b) if so, the details thereof;
- (c) the funds allocated and released year wise and State/UT wise for the last three years for Swadhar Greh Scheme; and
- (d) the number of beneficiaries under the scheme year-wise for the last three years?

#### **ANSWER**

# MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

- (a) & (b): Under the newly approved Mission Shakti, Swadhar Greh for women in difficult circumstances and Ujjawala Home for prevention of trafficking have been merged and known as Shakti Sadan, which is an Integrated Relief and Rehabilitation Home for the women in distress situations and difficult circumstances. The residents of Shakti Sadan are provided with shelter, food, clothing, counselling, primary health facilities, vocational training, other daily requirements, etc. under the scheme.
- (c) Shakti Sadan is a demand driven Centrally Sponsored Scheme wherein States/UTs forward proposals on the basis of requirement assessed by them, as per local needs and requirement of the States/UTs. The proposals of the States are considered in Programme Approval Board (PAB) at the Ministry. Funds are released to the States/UTs after approval of PAB. Year-wise and State/UT wise funds released during the last three years period is at **Annexure-I.**
- (d) The number of beneficiaries under Shakti Sadan (Swadhar Greh) year-wise for the last three years are given below:
