IMPLEMENTATION OF RKVY IN HIMACHAL PRADESH

176. Dr. Sikander Kumar:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the salient features of the Rashtriya Krishi Vikas Yojana (RKVY);
- (b) the details of projects initiated, funds allocated, utilised and released under RKVY in Himachal Pradesh so far;
- (c) the number and details of projects sanctioned/programmes implemented there under in Himachal Pradesh since 2018, district-wise;
- (d) the target set and achievements made so far;
- (e) the details of Krishi Vigyan Kendra (KVK) in Himachal Pradesh; and
- (f) whether Government has focused on digital agriculture under the Yojana and if so, the details thereof?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE

(a) : Rashtriya Krishi Vikas Yojana (RKVY) was launched in 2007-08. The scheme was revised with effect from 01.11.2017 as Rashtriya Krishi Vikas Yojana - Remunerative Approaches for Agriculture and Allied sector Rejuvenation (RKVY-RAFTAAR) with broad objectives of making farming a remunerative economic activity through strengthening the farmer's effort, risk mitigation with major focus on pre & post-harvest infrastructure. RKVY Scheme is rationalized from the financial year 2022-23 with the following components:

1. Per Drop More Crop
2. Sub-Mission on Agriculture Mechanization
3. Soil Health and Fertility
4. Paramparagat Krishi Vikas Yojna
5. Rainfed Area Development

6. Crop Diversification Programme
7. Agro Forestry
8. RKVY-Detailed Project Report (DPR)

Funds under the scheme are released to the State Governments/UTs as grant in aid for implementation of projects related to agriculture and allied sectors, approved by the State Level Sanctioning Committee (SLSC) headed by the Chief Secretary of the concerned State which is the empowered body on the matter. Under the rationalized RKVY scheme, the States/ UTs get financial flexibility to implement all the components as per their priorities and specific requirements.

(b), (c), (d) & (f): The details of projects initiated, fund allocated, released to Himachal Pradesh and utilized under the scheme from the financial year 2018-19 to 2022-23 are as under:

States have approved projects related to agriculture sectors such as horticulture, crops, agriculture mechanization, agriculture research, organic farming, micro and minor irrigation etc. for implementation under the scheme. No State specific target is set or district-wise allocation/ release of funds is made at the central level under the scheme. State can implement various projects in agriculture sector under the Scheme including Digital Agriculture as per its priority and requirements.
