RETRIEVAL AND BLOCKING OF STOLEN OR LOST MOBILE PHONES

1825 SHRI JAGGESH:

Will the Minister of Communications be pleased to state:

- (a) whether it is a fact that Government's initiatives to help consumers to retrieve or block stolen or lost mobile phones as well as identifying fake connections, are hitting a roadblock due to slow police action in the States;
- (b) if so, the number of cases registered for fraudulent Point of Sale (POS) holders, lost mobiles and fake connections in the country, State-wise; and
- (c) the number of cases identified so far for fraudulent POS holders, fake connections and recovery of lost mobiles, State-wise?

ANSWER

MINISTER OF STATE FOR COMMUNICATIONS (SHRI DEVUSINH CHAUHAN)

(a) to (c) Department of Telecommunications (DoT) has developed a portal called Sanchar Saathi, where users can register their lost/stolen mobiles. Such mobile handsets are blocked and cannot be used in Indian networks. The portal also allows tracing of such mobile handsets. The Licensed Service Area (LSA) wise details of registered First Information Report (FIRs) against fraudulent Point of Sale (PoS), number of fraudulent PoS and fake connections is enclosed at **Annexure A**.

The Licensed Service Area (LSA) wise details of number of lost/stolen/blocked mobile phones, traced mobile phones and recovered mobile phones is enclosed at Annexure B. DoT has requested all states to take proactive measures to trace and recover stolen handsets.
