SETTING UP OF PM MITRA PARKS IN MAHARASHTRA

1917. SHRI DHANANJAY BHIMRAO MAHADIK:

Will the Minister of TEXTILES be pleased to state:

- (a) whether Government proposes to launch a scheme of PM Mega Integrated Textile Region and Apparel (PM MITRA) parks in the next three years in Maharashtra;
- (b) if so, the details thereof;
- (c) details of textile parks established during last three years in Maharashtra;
- (d) whether there is any proposal to provide some incentives to the textile sector, particularly to those who have set up small units, to make them competitive, if so, details thereof; and
- (e) details of activities presently being undertaken with regard to textile parks in the State of Maharashtra, district-wise and if not, reasons therefor?

ANSWER

THE MINISTER OF STATE FOR TEXTILES (SMT. DARSHANA JARDOSH)

- (a) & (b): The Government has approved setting up of 7 PM Mega Integrated Textile Region and Apparel (PM MITRA) Parks across the country including one at Amravati in State of Maharashtra. These parks will be set up in Greenfield/Brownfield sites with world class infrastructure including plug and play facility. An outlay of Rs. 4,445 crore has been earmarked under the scheme upto 2027-28.
- (c) & (e): Details of district-wise textile parks under Scheme for Integrated Textile Park (SITP) in Maharashtra and activities undertaken is given in Annexure.
- (d): Government is implementing various other schemes to strengthen the Textile Value Chain across the country viz, PM Mega Integrated Textile Regions and Apparel Park (PM MITRA) Scheme, SAMARTH (Scheme for Capacity Building in Textile Sector), Silk Samagra, National Handloom Development Programme, National Handicraft Development Programme, Integrated Wool Development Programme, National Textile Mission, Scheme for Integrated Textile Parks etc. The Production Linked Incentive scheme particularly focuses on enhancing India's manufacturing capabilities.
