#### NAMAMI GANGE PROJECT

## 2010. DR. K. LAXMAN

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the details of the amount allocated and utilized under the Namami Gange Programme to Government of NCT Delhi;
- (b) the details of the number of projects sanctioned and the status of completion of such projects by Government of NCT Delhi in the last five years under the Namami Gange Programme;
- (c) the precautionary measures/projects which have been implemented or proposed to get prepared for situations like flood; and
- (d) if so, the details thereof?

#### **ANSWER**

#### THE MINISTER OF STATE FOR JAL SHAKTI

(SHRI BISHWESWAR TUDU)

(a) Namami Gange Programme was launched in June 2014 for a period up to 31<sup>st</sup> March, 2021 to rejuvenate River Ganga and its tributaries. The programme was subsequently extended up to 31<sup>st</sup>March, 2026. National Mission for Clean Ganga (NMCG) releases funds to SMCGs/Executing Agencies based on Annual Action Plans as when demanded and in lump sum. There is no state-wise allocation of budget under Namami Gange Programme.

National Mission for Clean Ganga has released Rs.1384.05 crore to Delhi Jal Board, Government of NCT of Delhi, from FY 2014-15 to 30 June 2023 for the cleaning of river Yamuna. Out of this, Rs.1253.85 crore has been utilized.

- **(b)** In Delhi, under Namami Gange Programme, a total of 11 projects at a cost of Rs.2009.12 crores have been sanctioned. These projects include 9 sewerage projects, 1 public outreach and 1 consultancy project. These projects are being implemented by Delhi Jal Board. Out of these 11 projects, 6 sewerage projects have been completed in the last 5 years. The details are annexed in **Annexure.**
- (c) & (d) Flood management including erosion control falls within the purview of the States. Flood management and anti-erosion projects are formulated and implemented by concerned State Governments from own resources as per their priority. The Union Government supplements the efforts of the States by providing technical guidance and also promotional financial assistance for management of floods in critical areas.

To strengthen the structural measures of flood management, Ministry had implemented Flood Management Programme (FMP) during XI & XII Plan for providing Central Assistance to States for works related to flood control, anti-erosion, drainage development, anti-sea erosion, etc. which subsequently continued as a component of "Flood Management and Border Areas Programme" (FMBAP) for the period from 2017-18 to 2020-21 and further extended up to September 2022 with limited outlay. In order to deal with the flood situation in the country, 527 projects have been taken up for funding under FMP component of FMBAP scheme since XI plan, out of which 427 projects have been fully completed and 64 projects have been completed with curtailed scope of work. Central Assistance of Rs. 8197 Cr. has been released to various States/UTs under FMBAP scheme of Government of India in order to provide flood protection to an area of around 4.994 Mha and protect a population of about 53.57 million.
