## DISBURSEMENT AND NON-DISBURSEMENT OF MMDA TO KHADI INSTITUTIONS

2041. SHRI ANEEL PRASAD HEGDE:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of Khadi Institutions (KIs) which have submitted their claims for Modified Market Development Assistance (MMDA) and the total number of Khadi Institutions to whom KVIC has disbursed MMDA since 1st January, 2022 to 31<sup>st</sup> March, 2023, Divisional Office (DO)-wise and State Office (SO)-wise, State-wise;
- (b) whether all Khadi Institutions have been given MMDA during this period, if not, the number of Khadi Institutions which have been given and not given MMDA; and
- (c) the reasons for non-disbursement of MMDA to such Khadi institutions, DO-wise and SO-wise, State-wise?

#### **ANSWER**

## MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

- (a): State Office/Divisional Office-wise details of number of Khadi Institutions which have submitted their claims for Modified Market Development Assistance (MMDA) and the number of Khadi Institutions(KIs) to whom the MMDA has been disbursed by Khadi and Village Industries Commission(KVIC) during 1<sup>st</sup>January, 2022 to 31<sup>st</sup> March, 2023 is given at Annexure.
- (b): The benefits under MMDA are extended to eligible KIs who upload their claims on MMDA Portal. Total 4477 number of claims have been uploaded by KIs on MMDA portal during 1<sup>st</sup> January, 2022 to 31<sup>st</sup> March, 2023, out of which MMDA have been disbursed for 3783 claims. 694 MMDA claims are pending during the said period.
- (c): The reasons for non-disbursement of MMDA are due to non-submission of requisite documents by KIs on deposit of artisan's wages into artisan's bank accounts, details of procurement of raw material, audit reports etc.
