Will the Minister of **Chemicals and Fertilizers** be pleased to state:

(a) the number of operational and closed Janaushadhi Kendras under Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJYP) in the last five years, year-wise, State-wise and district-wise for Punjab;

(b) the number of beneficiaries especially women and below poverty line beneficiaries under the PMBJP in the last five years, year-wise, State-wise and district-wise for Punjab; and(c) the details of the funds allocated and utilized by BPPI (Bureau of Pharma Public Sector Undertakings of India) in the last five years, year-wise, State-wise and district-wise for Punjab?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI BHAGWANTH KHUBA)

(a): The details of *Pradhan Mantri Bhartiya Janaushadhi Kendras* (PMBJKs) opened and closed during the last five financial years, State/UT-wise is enclosed as **Annexure-I.** District-wise list of PMBJKs opened and closed during last five financial years in the state of Punjab is enclosed as **Annexure-II.**

(b): As per estimates, about 10- 12 lakh people buy medicines on an average daily basis from *Jan Aushadhi Kendras* all across the country. State/UT-wise and district-wise data has, however, not been exactly quantified.

(c): The details of the funds allocated and utilized under the *Pradhan Mantri Bhartiya Janaushadhi Pariyojana* implemented by the Pharmaceuticals & Medical Devices Bureau of India (PMBI) [erstwhile Bureau of Pharma PSUs in India (BPPI)] during the last five financial years is as under:
