PROMOTION OF STARTUPS IN THE COUNTRY

QUESTION

2119 SHRI S. SELVAGANABATHY:

Will the Minister of Corporate Affairs be pleased to state :

- (a) whether Government has registered new startups in the country during the last five years;
- (b) if so, the details of registration of startups and other categories of limited liability partnership, private limited and limited company, year-wise, product-wise and State-wise;
- (c) the activation report in comparison to registration of such companies since 2018; and
- (d) the list of new Government companies that have been registered during the last five years?

ANSWER

(a) & (b) : Yes Sir. In order to build a strong ecosystem for nurturing innovation, startups, and encouraging private investment in the startup ecosystem of the country, the Government launched the Startup India initiative on 16th January 2016. The Department for Promotion of Industry and Internal Trade, Ministry of Commerce & Industry recognized the Startups and the Startups recognized during the last five years are as under: -
