OBJECTIVES OF SKILL DEVELOPMENT PROGRAMME

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

(a) whether Government has achieved the target of skill development programme of providing skill and training to 30 crore people by the year 2022, if not, the reasons therefore;

(b) whether closure of training centres has been reported due to inadequate training facilities and lack of basic education by Government in the skill development and entrepreneurship schemes, if so, the details thereof; and

(c) the Stae-wise details of the centres in operation for providing employment through skill development?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(a) The estimated number of persons in the workforce in 2014-15 without any formal skilling and for which there was need for skilling, re-skilling and up-skilling was 29.82 crore and the estimated number of fresh entrants into workforce between 2015-22 requiring skilling was about 1.5 crore per year, as per the National Policy for Skill Development and Entrepreneurship 2015.

The Skill India Mission (SIM) of the Government of India is aimed at skilling, re-skilling and up-skilling to ensure our youth are prepared for the large number of opportunities coming up as the economy expands and India moves from the 10th largest economy to 3rd largest economy in the world. SIM is aimed at future ready and Industry ready talent among the youths.

Under SIM, Ministry of Skill Development and Entrepreneurship (MSDE) delivers Skill, Re-Skill and Up-Skill training to all the sections of the society, through an extensive network of skill development Centres/ Institutes across the country, under various schemes viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsmen Training Scheme (CTS) through Industrial Training Institutes (ITIs). All the schemes of MSDE are demand driven and the number of persons benefitted through these schemes is as under:

In addition, 209 Lakh persons were provided fee-based training by NSDC till March, 2023. Apart from above, more than 20 Central Ministries are implementing Skilling/upskilling training programmes through various schemes. A total of 14.03 Lakh persons have been trained under Deendayal Antyodaya Yojana – National Urban Livelihoods Mission (DAY-NULM) of Ministry of Housing and Urban Affairs (MoHUA) till March, 2023. Further, 14.23 Lakh persons have been trained under Deen trained under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) till March, 2023 and 33.64 Lakh persons have been trained under Rural Self Employment Training Institutes (RSETIs) till December, 2022 of Ministry of Rural Development.

(b) & (c) Under PMKVY, there is provision for taking suitable action against erring / noncompliant training centres / stakeholders as per penalty grid framework. Based on the penalty grid, National Skill Development Corporation (NSDC), the implementing agency of PMKVY under MSDE, has suspended 358 training centres for non-compliance of PMKVY guidelines on multiple parameters.

The State-wise number of skill development centres providing skill training across the country is at **Annexure-I**.
