(a) & (b) Ministry of Culture administers a scheme by the name of "Financial Assistance for Veteran Artists" for improving the financial and socio-economic status of the old artistes and scholars who have contributed significantly in their specialized fields of arts, letters etc. in their active age or are still contributing in the field of arts, letters etc. but due to old age they have to lead a miserable life or are in penury condition. The amount spent on financial assistance provided to veteran artists including authors or their survivors in indigent circumstances and number of recipients during the last five years is given as under:-
