CONSUMPTION AND PRODUCTION OF EDIBLE OIL

2630 SHRI G.C. CHANDRASHEKHAR:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

(a) the percentage, quantity and country-wise imports along with consumption of edible oils and oil seed production in the country, seed type-wise from 2019 to till date; and

(b) whether it is a fact that the country's edible oil imports have surged to 15 million tonnes from 4 million tonnes only two decades ago, if so, the details thereof with the reasons therefor?

(a): The percentage and quantity of imports along with consumption of edible oils are at Annexure I. The country-wise imports of edible oils are at Annexure II. The seed type -wise oil seed production in country is at Annexure III.

(b): India imported around 43.65 LMT of edible oils during oil year (Nov-Oct) 2002-03, which increased to 141.93 LMT in oil year 2021-22. The domestic production of edible oilseeds increased marginally. However, domestic consumption/demand for edible oils has been increasing at the pace faster than that of production due to growth in population and improvement in the living standards of people i.e. around 10 LMT per annum. Therefore, domestic production of edible oils is insufficient to meet the demand and the shortfall, which is around 55% at present, is met through imports.
