(c) & (d) Automatic cancellation of tickets after preparation of first chart occurs in case of eticket passengers only. As per "Railway Cancellation of tickets and Refund of Fare Rules 2015", in case of waitlisted e-tickets on which status of passengers who are on waiting list even after the preparation of reservation chart appears, names of all such passengers booked on that Passenger Name Record (PNR) is dropped from the reservation chart and refund of fare is credited to the account from which booking transactions took place after deducting applicable clerkage charges. Details of amount recovered in cancellation charges is part of Miscellaneous Coaching Receipts, details of which are provided in part (a) of the reply.
