DECLINE IN EXPORT OF HANDLOOM PRODUCTS

2717. SHRI B. LINGAIAH YADAV:

Will the Minister of TEXTILES be pleased to state:

- (a) whether apparel exports contracted 11.3 per cent year-on-year in June even as many textile mills in the South suspended production due to tepid demand and export of cotton yarn, fabrics, made-ups and handloom products slid 1.21 per cent year-on-year;
- (b) whether shipment of man made products saw a 17.2 per cent decline while export of jute products and carpets plunged 26.7 per cent and 15.4 per cent, respectively; and
- (c) if so, the details thereof since 2017 onward to till date, State-wise exports including Telangana and present status thereof along with future action plan?

Government has approved the Production Linked Incentive (PLI) Scheme for Textiles with an approved outlay of Rs.10,683 crore to promote production of MMF Apparel, MMF Fabrics and Products of Technical Textiles in the country to enable textiles industry to achieve size and scale and to become competitive. Government has also approved setting up of 7 PM Mega Integrated Textile Region and Apparel (PM MITRA) Parks across the country including State of Telangana. These parks will be set up in Greenfield/Brownfield sites with world class infrastructure including plug and play facility. An outlay of Rs. 4,445 crore has been earmarked under the scheme upto 2027-28.
