# DEMARCATED VENDING ZONE FOR STREET VENDORS

### NO. 389. SMT. SULATA DEO:

# Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the number of States and Union Territories which have issued more Letter of Recommendation (LoR) than certificates of vending and steps taken to address this disparity;
- (b) the data on adherence to the activities outlined in the Protection of Livelihood and Regulation of Street Vending Act, 2014 including the formation of provisional Town Vending Committee (TVC), survey conduct, formation of regular TVC, issuance of certificate of vending and ID Card, formulation and approval of city vending plan, and allotment of spaces to vendors; and
- (c) the measures which are being taken to ensure street vendors with LoR have designated Vending Zones for legal vending?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

- (a): There are 15 States/UTs which have issued more number of Letter of Recommendation (LoR) than Certificate of Vending (CoV). Urban Local Bodies (ULBs)/ Town Vending Committees (TVCs) have been authorized to issue LoR to extend the benefits of Prime Minister Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) Scheme to the street vendors, who have been left out of the ULB led survey or who started vending after completion of the survey. The States/UTs have been advised to complete fresh survey of street vendors as per Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 and issue CoV to surveyed vendors at the earliest.
- (b): As on 30.06.2023, State/UT-wise details of formation of provisional and regular TVC, number of cities completed street vendors survey, number of CoV and Identity Card (ID card) issued and number of formulated/approved city vending plan are at **Annexure-I.** Details of allotment of spaces to vendors are not maintained at the level of Ministry of Housing and Urban Affairs (MoHUA).
- (c): To ensure street vendors with LoR have designated vending zones for legal vending, all States/UTs have been instructed to formulate and implement city vending plan as per Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014.
