STATUS OF MICRO, SMALL AND MEDIUM ENTERPRISES (MSMEs)

443. SHRI SANDEEP KUMAR PATHAK:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) number of active MSMEs in the country, number of such MSMEs which could not be registered and number of MSMEs shut down during the last five years;
- (b) number of MSMEs registered with GST as compared to total number of MSMEs;
- (c) whether it is a fact that in micro, small and medium industries, micro industry is about 99 per cent while share of micro industries in total loans received by these industries is only 20 per cent;
- (d) if so, the reasons therefor, if not, details thereof; and
- (e) year-wise details of loan provided to MSMEs and amount converted into NPA in the last five years?

(a): As on 18.07.2023, as per Udyam Registration Portal, the total number of MSMEs which were registered since inception 01.07.2020 to 18.07.2023 in all India are 1,75,62,223.

As on 18.07.2023, as per Udyam Registration Portal, the total number of MSMEs which were shutdown during 01.07.2020 to 18.07.2023 were 24,839.

(b): As per the information received from Department of Revenue, Ministry of Finance the number of Micro, Small and Medium Enterprises having GSTINs are 1,36,16,729.

(c) & (d): Under Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) scheme, 78% guarantees were issued to micro enterprises during the year 2022-23.

(e): As per the information received from Reserve Bank of India, year wise data related to credit outstanding to MSME sector by Scheduled Commercial Banks for last five years is given below:
