- (a) to (c): In the Budget Speech for 2018-19, the then Hon'ble Finance Minister had announced that NITI Aayog will develop a National Program on AI, to guide the Research & Development of new and emerging technologies. Pursuant to the Budget Announcement, NITI Aayog had released the 'National Strategy for Artificial Intelligence' (NSAI) in 2018 (Access Link: https://niti.gov.in/sites/default/files/2019-01/NationalStrategy-for-AI-Discussion-Paper.pdf). Subsequently, on the various recommendations of NSAI, policy papers were released from time to time. Responsible Artificial Intelligence (RAI) is one such area where NITI Aayog has been extensively working. The following papers were subsequently released, after Inter-Ministerial and Stakeholder Consultations:
