Loans taken by Government

544. SHRI SANDEEP KUMAR PATHAK:

Will the Minister of FINANCE be pleased to state:

- a. The total debt of the country and that of Government at present and the details of the debt on the State Governments, State-wise; and;
- b. The details of the countries, financial institutions, local markets including RBI from where the Central Government has taken loan along with their purposes in the last five years, the country-wise, year-wise, institution-wise and purpose-wise details of the said loan amount?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PANKAJ CHAUDHARY)

- a) The amount of the Central Government debt as on 31st March, 2023 is ₹ 155.60 lakh crore and State Governments' estimated debt is ₹ 76.10 lakh crore. State-wise details of the State Governments' debt are provided at **Annexure-I.**
- b) To finance its fiscal deficit, the Central Government mobilizes funds from internal and external resources. Funds are utilized to finance infrastructure development, health, education, agriculture and other welfare schemes/programmes etc. of the Government.

The Investor group wise details of Market loans raised through dated securities (G-Secs) by the Central Government in the last five years are provided at **Annexure-II**. The Central Government also avails assistance from the Multilateral and Bilateral International Financial Institutions/Agencies, mainly to meet the requirement of the Central/State development projects etc. The details of major International Financial Institutions/Agencies from whom the assistance has been availed during the last five years are provided at **Annexure-III**.
