REVIVAL OF CIP, RANCHI

591. SMT MAHUA MAJI:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether the Central Institute of Psychiatry (CIP), Ranchi is gradually crumbling down and whether there is any plan to revive the institution as an institution of national importance or a centre of excellence or a deemed university or in the pattern of NIMHANS, Bengaluru;
- (b) if so, the details of timeframe; and
- (c) if not, the reasons therefor?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (PROF. SATYA PAL SINGH BAGHEL)

(a) to (c) Central Institute of Psychiatry Ranchi, Jharkhand is a premier institution in mental health in India established on 17th May, 1918 with the name of Ranchi European Lunatic Asylum. On 1st June 1954, the Board of Trustees was abolished and the Govt. of India, Ministry of Health took over the institute under administrative control of Dte.GHS. On April 1, 1977, it was raised to the status of an institute and was named as Central Institute of Psychiatry (CIP). A century-old institution with a rich history, the Institute continues to provide quality clinical services as well as being at the forefront of cutting edge research in mental health along with training professionals in the field of mental health.

In the year 2022, 29 National and International Research Papers were presented and published by the Institute. Institute has a current capacity of 643 beds among 15 wards (nine male wards and six female wards), an emergency ward and a family unit. In the year 2022, 4332 patients (3368 males and 964 females) were admitted. The average bed occupancy during the specified period was 77.8%. The number of people seeking treatment for mental health issues in Central Institute of Psychiatry (CIP), Ranchi in the last two years is as under:
